## JCHC's Legislative Initiatives 2010 Session

### **SB 260 – Senator L. Louise Lucas**

Amend *Code* §37.2-416.C to allow an individual with a conviction of assault against a family member (related to individual's mental illness or substance abuse) to be assessed for employment in a private behavioral health care facility that serves adults.

*Passed the Senate (40-0) but was amended to conform to HB 867 before passing in the House (71-27). The committee of conference was unable to reach agreement, so SB 260 failed to pass. (HB 867 was continued to 2011 in Senate Education and Health.)*

### **SB 706 – Senator R. Edward Houck**

Amend *Code* §38.2-3412.1 to repeal mental health benefit limitations for large group markets while maintaining the mandate to provide coverage for specified mental health services.

*Passed both Chambers on unanimous votes.*

### **HB 306 - Delegate John M. O'Bannon**

Amend the *Code* to add an Article 2 to Section 8.01-581.20 authorizing a pilot program regarding the use of disclosures, apologies and other measures related to adverse medical outcomes.  
*Continued to 2011 in House Courts of Justice.*

### **HJ 83 - Delegate Robert H. Brink**

Request for JLARC study of the costs and benefits of implementing the Home and Community-Based Services State Plan Option.  
*Left in House Rules*

### **HJ 56 - Delegate Rosalyn R. Dance**

Request for the Cancer Plan Action Coalition to present updated Virginia Cancer Plans to JCHC.  
*Passed both Chambers on unanimous votes.*

### **SJ 51 - Senator Linda T. Puller**

Request for JLARC study of the funding and administration of the LTC Ombudsman program.  
*Passed by indefinitely in Senate Rules.*

# Proposed JCHC Studies

## Study Resolutions Approved

### HJ 27 – Delegate Harry R. Purkey

*Staff: Stephen Bowman*

Directs JCHC to (i) determine the volume of indigent health care provided by private, specialty, and not-for-profit hospitals; (ii) determine the financial cost of indigent health care to private, specialty, and not-for-profit hospitals; and (iii) identify and analyze potential tax and other incentives that may be offered to private and specialty hospitals and other health care providers to encourage the provision of care to indigent individuals.

### HJ 82 – Delegate Patrick A. Hope

*Staff: Jaime Hoyle*

Directs JCHC to review available information including information about chronic health care home systems in other states to develop recommendations related to the development of a system of chronic health care homes.

### HJ 99 – Delegate Christopher P. Stolle

*Staff: Stephen Bowman*

Directs JCHC to (i) determine the availability and usage of catastrophic health insurance policies, (ii) examine the results of efforts in other states to increase the use of catastrophic health insurance policies, and (iii) evaluate the potential benefits and risks of facilitating the offering within the Commonwealth of health insurance policies or plans that provide catastrophic coverage only.

### SB 266 - Senator Mary Margaret Whipple

Review of issues surrounding changing eligibility levels in FAMIS program from 200 to 225% FPL.

### HB 512 - Delegate Thomas D. Rust

Review of issues surrounding physicians prescribing long-term antibiotic therapy for Lyme disease.

### HB 867 - Delegate Benjamin L. Cline

*Staff: Kim Snead*

Review of whether to repeal allowance for CSBs to screen consumers, with one misdemeanor conviction of assault on a family member, to work in adult facilities.
